Chairman Free announced the merging of James City County with Williamsburg. The new unit will be known as Williamsburg/James City County. Jeff Ryer presented the details of the merger as well as the reasons supporting the merger. The committee had voted to support this merger by electronic means and James City County approved the merger. Williamsburg no longer had a functioning committee.

The committee voted to reinstate Carolyn Weems as a member of state central. This was due to a new interpretation of the party plan rules requiring a member to make half of the meetings each year rather than half of the meeting during the members four year term.

With the court ruling that the Incumbent Protection Act was not constitutional the committee voted 12 to 4 to hold a primary as a means of selecting our candidates for the Second Congressional District.

Key in the call was a filing fee of \$1500 for each candidate filing for chairman and that if only one candidate files for chairman then that person will be declared the chairman and the convention would be cancelled. With a vote of 16 to 0 the requirement that the call be placed in a newspaper was waived.

Linda Fairman was appointed as the new treasurer. A treasury report was presented by Chairman Free. The bank balance of \$6,547.96 exactly matched the state report.

The meeting was adjourned at 7:50 PM.
